

## FAST-AID LIMITED WARRANTY (USA ONLY)

The Limited Warranty set forth below is given by Valley Sheet Metal Marketing, Inc. (VSMM) with respect to the VSMM Fast-Aid Medical Center that you have purchased, when purchased in and used in the United States. The Fast-Aid Medical Center that you have purchased is the only Fast-Aid Medical Center to which this warranty card and the limited warranty provided by VSMM and stated on the card apply.

Your Fast-Aid Medical Center, when delivered to you in new condition and in its original container, is warranted against defects in materials and workmanship as follows: for a period of one (1) year from the date of original purchase, defective parts or a Fast-Aid Medical Center returned to VSMM and proven to be defective upon inspection, will be exchanged for new or comparable or rebuilt parts, or a refurbished Fast-Aid Medical Center, as determined by VSMM. Warranty replacement shall not extend the original warranty period of the defective Fast-Aid Medical Center.

The limited warranty covers all defects encountered in normal use of the Fast-Aid Medical Center, and does not apply in the following cases:

- (a) Loss of or damage to the Fast-Aid Medical Center due to abuse, mishandling, improper packaging by you, alteration, accident, failure to follow operating, maintenance or environmental instructions prescribed in VSMM's instruction or owner's manual, or service performed by other than VSMM.
- (b) Use of parts or supplies (other than those sold by VSMM) which cause damage to the Fast-Aid Medical Center or cause abnormally frequent service calls or service problems.
- (c) If any Fast-Aid Medical Center has had its serial number or dating altered or removed.

NO IMPLIED WARRANTY, INCLUDING ANY IMPLIED WARRANTY OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, APPLIES TO THE FAST-AID MEDICAL CENTER AFTER THE APPLICABLE PERIOD OF THE EXPRESS LIMITED WARRANTY STATED ABOVE, AND NO OTHER EXPRESS WARRANTY OR GUARANTEE, EXCEPT AS MENTIONED ABOVE, GIVEN BY ANY PERSON OR ENTITY WITH RESPECT TO THE FAST-AID MEDICAL CENTER SHALL BIND VSMM. (SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.) VSMM SHALL NOT BE LIABLE FOR LOSS OF REVENUES OR PROFITS, INCONVENIENCE, EXPENSE FOR SUBSTITUTE EQUIPMENT OR SERVICE, STORAGE CHARGES, OR ANY OTHER SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES CAUSED BY THE USE OR MISUSE OF, OR INABILITY TO USE, THE FAST-AID MEDICAL CENTER, REGARDLESS OF THE LEGAL THEORY ON WHICH THE CLAIM IS BASED, AND EVEN IF VSMM HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL RECOVERY OF ANY KIND AGAINST VSMM BE GREATER IN AMOUNT THAN THE ORIGINAL PURCHASE PRICE OF THE FAST-AID MEDICAL CENTER SOLD BY VSMM AND CAUSING THE ALLEGED DAMAGE WITHOUT LIMITING THE FOREGOING, YOU ASSUME ALL RISK AND LIABILITY FOR LOSS, DAMAGE OR INJURY TO YOU AND YOUR PROPERTY AND TO OTHERS AND THEIR PROPERTY ARISING OUT OF THE USE OR MISUSE OF, OR INABILITY TO USE, THE FAST-AID MEDICAL CENTER NOT CAUSED DIRECTLY BY THE NEGLIGENCE OF VSMM. (SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU.) THIS LIMITED WARRANTY SHALL NOT EXTEND TO ANYONE OTHER THAN THE ORIGINAL PURCHASER OF THE FAST-AID MEDICAL CENTER, OR THE PERSON FOR WHOM IT WAS PURCHASED AS A GIFT, AND STATES YOUR EXCLUSIVE REMEDY.

In order to obtain warranty service call the VSMM service center at 1-800-359-3606 from 8:00 a.m. to 5:00 p.m., (MST) Monday through Friday, excluding holidays. Please have your serial number and your date of purchase available when you make your call to expedite service. A VSMM representative will attempt to diagnose the nature of the problem and correct it over the telephone. If the problem cannot be corrected over the telephone, you will be asked to return your Fast-Aid Medical Center to VSMM for repair or replacement.
